NOTICE TO MEMBERS:

Re: Updates and Changes to Continuing Professional Development – Law Society of Yukon – May 2020 and Updated October 2020

This is a reminder that under rule 94 of the Rules of the Law Society of Yukon, members must complete, by December 31, one hour of CPD activities for each full or partial month during the calendar year the member was an active member. Under rule 96 a member who was active any time during the calendar year must by January 31 of the next year, file with the Executive Director a CPD Report in Form 16 setting out the number of months during the year the member was active and the CPD activities completed by the member. A reminder notice and blank Form 16 – CPD Report will be circulated to members in December of each year.

<u>Take note that members who completed education requirements of a law society in a comparable jurisdiction in Canada are no longer exempt under the new Rules.</u>

Members who are also called in another jurisdiction must now meet the requirements set out in rule 94 and report their CPD hours under rule 96 by January 31 of the following calendar year. It is no longer sufficient to indicate that you have met the requirements in a comparable jurisdiction.
